#### **Cultural District Accomplishments and Growth during 2022**

The Original Denton District continues on a promising recovery trajectory from the dark days of the late pandemic. In FY 2021 we saw the reopening of existing restaurants, bars, cultural venues, and other businesses. For FY 2022 our gradual return to normalcy has witnessed a plethora of new businesses opening within the district. Notable new businesses on the square itself include an artisinal tattoo parlor (American Tattoo), Italian gelateria (Two Gentlemen of Verona), a bar for DnD and turn-based game enthusiasts (d20Tavern), and a combined pasta restaurant, bar, and late-night music venue (Graffiti Pasta).

This past year also witnessed a number of new businesses opening up across the Original Denton District outside of the square itself. Notable new businesses added District-wide include a plant nursery (The Brown Thumb), a cocktail bar (VYB Lounge), a bank branch (Plainscapital Bank), and several new restaurants (Shuck Me, TAAN Eatery, El Taco H, Namaste Denton, and Picone).

This impressive new business openings were also joined by significant changes made to existing buildings in the Original Denton District. The year witnessed around \$2 million in investments to existing structures - both in service of housing new businesses and in renovations made to existing businesses. Additional changes were made to Wolff's Park in 2022 as well, including improved lighting. In 2022, Wolff's park very quickly established itself as a cultural anchor within the Original Denton District. The park hosted our autumnal Twilight Tunes series, offering a cozier outdoor space for these smaller concerts, when compared to their usual home on the Courthouse Square.

In another positive indication of a post-pandemic return to normalcy, The Original Denton District played host to a full calendar of events in 2022. The Arts and Jazz Festival, perhaps the signal event in Denton's cultural calendar, made a permanent change from a spring to fall event. This seasonal shift first happened in 2021, when the festival was delayed into the fall because of pandemic-related delays. Other significant events occurring within the Original Denton District in 2022 included the Holiday Lighting Festival, Denton Black Film Festival, Day of the Dead celebration, Texas Storytelling Festival, Fall and Spring Twilight Tunes series, Denton Redbud Festival, and Denton Juneteenth Celebration. City staff and community leaders also began an effort to commemorate Quakertown, a community of African Americans who were displaced in the 1920s when the City decided to build Quakertown Park.

#### **Cultural District Visitors**

Available data provide a figure of approximately 462,054 This figure represents sustained growth from 2021 when the available data provided an attendance figure of 458,221 visitors. These numbers include only in-person events, as most events no longer rely on virtual components.

Individual event and venues varied in terms of the number of attendees from within and outside of Denton. For example, the Arts and Jazz festival and Denton Black Film Festivals attracted significant visitors, while the Redbud Festival and Holiday Lighting had a larger majority of local attendees. Overall estimates indicate a visitor figure of roughly 34% of the overall attendance figure or around 157,098 external visitors.
