


# Process for Easement Requests through Public Park Property & Application

# Flow Chart Obtaining Easements Across Parkland



#### Process for Easement Requests through Public Park Property

Developer to provide the following documents (electronically):

- Application for Permanent and Temporary Use of Parkland
- Site location exhibit
- Aerial with overlay of installation (i.e. waterline, sanitary sewer, electrical)
- Legal Descriptions
- Survey
- Tree Survey
- Narrative

Once received:

- Real Estate
  - Contact to obtain value of easement
  - o If required, obtain appraisal at developer's cost
- Negotiate Easement Fee
- Park Board
  - Schedule Park Board: Developer or designee must attend
  - Prepare package for Park Board to include:
    - Exhibit 1 AIS
    - Exhibit 2 Presentation
    - Exhibit 3 Aerial Map
  - Present to Park Board
    - Obtain vote

- Update ordinance draft to reflect vote
- Draft Ordinance
  - Submit to legal (this may be submitted prior to Park Board with vote listed as: TBD)
    - If easement is likely to be contentious, do not submit prior to Park Board
  - Complete Ordinance Package for City Council
    - Exhibit 4: Ordinance
      - Ordinance
      - Legal Description "Exhibit A" Attachment 1
      - Survey "Exhibit B" Attachment 2
      - Notice by City Manager Attachment 3
- Advertisement
  - Notice at least 30 days prior to public hearing, no less that one week or more than two weeks before hearing, three consecutive weeks
- City Council
  - Schedule Council Date
  - Submit for Legistar upload

  - A. Confirm that all Areas requested are correct.
  - B. Changes in Requested Areas after presentation could require additional presentations at the next scheduled meetings.
  - C. Survey and Field Notes must be obtained prior to presentation to Land, Facilities & Programs Committee, Parks Board and Council.
