Free Camp Scholarship Policy 2023

I. PURPOSE

The purpose of the policy is to provide guidelines for the application and distribution of Community Development Block Grant (CDBG) funded scholarships for Denton Parks and Recreation ("PARD") summer camps.

II. POLICY

The scholarship policy establishes the eligibility requirements, distribution, award level, and guidelines that apply to all PARD programs for which a fee is charged. The Scholarship Program will serve children and youth, ages 3-15 who wish to participate in PARD all-day summer camps. It is the desire of the Denton City Council that scholarships exist to execute the mission of PARD by assisting low-income families and subsidizing costs associated with PARD programs and events, in accordance with guidelines set forth by the City Council.

III. ELIGIBILITY

- Applicants are required to be City of Denton residents and must provide proof of residency (current DME utility bill, current Denton driver's license, apartment/housing lease with a driver's license, or verification of City of Denton Taxing District on CAD).
- Applicants are required to provide proof of Moderate Extremely Low Income and must provide a copy
 of the free or reduced lunch approval letter from the Denton Independent School District (DISD) or
 current year completed IRS tax forms.
- Applicants are required to provide a birth certificate, adoption papers, foster parent agreement, or other court documentation showing the main account holder has legal guardianship over the summer camp participant(s).
- Applicants are required to complete the Self-Certification Income Form.

IV. APPLICATION

Complete the Scholarship Application Form, using one form per family, listing all eligible family members. Provide required documentation for proof of eligible services. Email the information to scholarships@cityofdenton.com or bring it to any recreation center. Applications must be completed by a parent or guardian if the recipient is under the age of 18.

Each family may request up to 18 weeks of all-day summer camp and up to 10 days of Kids' or Teens' Day Off. This can be split between 2 or more children per family. Families are encouraged to only request the number of weeks necessary.

Scholarship eligibility doesn't guarantee admittance or available space for all programs and events as funding is determined by budget allocations each fiscal year. Scholarship funding is awarded on a first come, first served basis. Incomplete applications cannot be accepted and will delay the review and approval process.

Recreation staff will review all applications for completeness. Applications will be processed within 5 business days after all documentation is received and verified. Applicants will be notified by email of their status after the application has been processed.

V. DISTRIBUTION

Scholarships may be awarded up to the maximum allowed request. However, scholarships are awarded on a first come, first served basis. Due to the limited number of scholarships available, some applications may be awarded a partial benefit.

Recipients of scholarships will be notified by email and phone once they have been awarded a scholarship.

Recipients have 24 hours from notice of award to accept or decline any portion of the awarded scholarship. Failure to provide the above-stated notice will result in the recipient losing the awarded scholarship allocations.

VI. PROGRAM GUIDELINES

Each participant will receive up to a maximum benefit of \$1,290 for All-Day Summer Camp Weeks 1-9 and Kids' or Teens' Day Off from July 31 -August 4, 2023. A scholarship credit will be placed on each participants' account.

- After scholarship approval is awarded, participants are responsible for registering for their selected camp(s) on or after Summer Camp Registration Day. Registration will open April 10, 2023, at 8 a.m.
- Scholarship approval does not guarantee a space in any specific summer camp. All registrations are first come, first served. Participation limits are set for each location due to staffing and transportation and are subject to change.
- Register for camps online at www.dentonparks.com, by phone, or in-person at any Denton recreation center.

Absence Policy

Free camp scholarship participants must abide by the following attendance and withdraw policies:

- Parents must withdraw campers five (5) business days in advance. Withdraw by calling (940)349-7275, emailing scholarships@cityofdenton.com, or in person at the Civic Center.
- Any camper missing five consecutive days for which they are registered for without withdrawing from that week of camp, will be dropped from all additional registered weeks of camp. This includes absences due to behavior, illness, vacations, death in the family, school events, or any other personal or family reason. Absences due to illness or injury will require immediate notice and a doctor's note to remain eligible.
- A second violation of the absence policy will result in the participant becoming ineligible to apply for any PARD scholarships or other free or subsidized camp program for a full two years from the date of occurrence.

All scholarships are non-transferable, and they cannot be replaced with additional scholarship funds due to the non-use of the original scholarship.

VII. MAXIMUM ELIGIBILITY

Each family may receive a maximum benefit of \$2,580, which equates to 18 weeks of all-day summer camp and 10 days of Kids' or Teens' Day Off. This benefit can be split between 2 or more children per family. Scholarship funding is available on a first come, first served basis.

VIII. TERMINATION

Scholarship recipients who are found to provide false eligibility information to the City will immediately forfeit their scholarship for this year and remain ineligible for the following two years.

Household accounts that have a past due balance for any PARD program will not be eligible for a scholarship until the balance has been paid in full.

I understand that I must withdraw my child five (5) business days in advance of a registered camp week by calling (940)349-7275, emailing scholarships@cityofdenton.com, or in person at the Civic Center. Any camper missing five consecutive days for which they are registered for will be dropped from all additional registered weeks. This policy is in effect even if the absences are due to illness, vacations, death in the family, school events, behavior or any other personal or family reason. If the camper was removed from camp due to the absence policy the previous year the camper will be unable to apply for any PARD scholarships or other free or subsidized camp program for a full two years from the date of second occurrence.

I acknowledge that I have been provided a full copy of the free summer camp scholarship policy. I agree to abide by this policy and follow all summer camp rules and regulations including the attendance and withdraw policies.

Política de becas para campamentos gratuitos del año 2022

I. OBJETO

El objeto de la política es facilitar pautas para la solicitud y distribución de becas para programas y eventos del Departamento de Parques y Recreación de Denton ("PARD").

II. POLÍTICA

La política de becas establece los requisitos de elegibilidad, la distribución, el nivel de concesión y las pautas que se aplican a todos los programas del PARD por los que se cobra una tarifa. El Programa de Becas atenderá a niños, jóvenes, adultos y personas mayores. Es el deseo del Concejo Municipal de Denton que existan becas para ejecutar la misión del PARD al ayudar a familias de bajos ingresos y subsidiar los costos asociados con los programas y eventos del PARD, de acuerdo con las pautas establecidas por el Concejo Municipal.

III. ELEGIBILIDAD

- Se exige que los solicitantes sean residentes de la Ciudad de Denton y deben facilitar un comprobante de residencia (factura actual de servicios públicos, licencia de conducir, contrato de arrendamiento del apartamento o la vivienda, **o bien** verificación del Distrito Fiscal de la Ciudad de Denton en el Distrito Central de Tasación [CAD]).
- Se exige que los solicitantes presenten un comprobante de ingresos moderados a extremadamente bajos y deben facilitar una copia de la carta de almuerzos gratuitos o a precio reducido del Distrito Escolar Independiente de Denton (DISD) o bien formularios de impuestos del Servicio de Impuestos Internos (IRS) del año en curso.
- Se exige que los solicitantes diligencien el formulario de certificación general de ingresos **y** el formulario de autocertificación de ingresos.

IV. SOLICITUD

Diligencie el formulario de solicitud de becas (un formulario por familia) indicando todos los familiares elegibles. Facilite la documentación exigida como comprobante de los servicios elegibles. Envíe la información por correo electrónico a scholarships@cityofdenton.com o llévela a cualquier centro de recreación. Las solicitudes deben ser diligenciadas por uno de los padres o tutor si el beneficiario es menor de 18 años.

La elegibilidad para becas no garantiza la admisión o el cupo disponible para todos los programas y eventos, ya que la financiación está determinada por las asignaciones presupuestarias de cada año fiscal.

El personal del Departamento de Parques y Recreación revisará las solicitudes. Las solicitudes se procesarán en un lapso de 10 días hábiles posteriores a la recepción y verificación de toda la documentación. Los solicitantes serán notificados por correo electrónico de su condición después de que se haya procesado la solicitud.

V. DISTRIBUCIÓN

Los beneficiarios de becas tienen cinco (5) días hábiles a partir de la notificación de la concesión para cancelar o rechazar la beca. Si no se facilita dicha notificación, el beneficiario perderá las asignaciones de becas restantes y el participante no será elegible para ninguna beca adicional durante dos (2) años completos a partir de la fecha del incumplimiento.

VI. PAUTAS DEL PROGRAMA

Las becas para campamentos gratuitos se ciñen a las siguientes políticas:

- Los campistas deben asistir al menos ocho horas de campamento al día.
- Si un campista asiste a un día de campamento por menos de ocho horas, esto se considerará una ausencia. Para recibir crédito por asistir al campamento, el niño debe asistir al menos ocho horas. entre las 7 a. m. y las 6 p. m.
- Cualquier campista que falte cinco días consecutivos o 10 días en total será expulsado del campamento. Esto incluye ausencias por comportamiento, enfermedad, vacaciones, muerte en la familia, eventos escolares o cualquier otra razón personal o familiar.
- Si el campista ya no puede asistir debido a la política de ausencias, la cuenta del participante no será elegible para solicitar ninguna beca del PARD ni otro programa de campamentos gratuitos o subsidiados durante dos años completos a partir de la fecha de ocurrencia.

Todas las becas son intransferibles y no pueden reemplazarse con fondos de becas adicionales debido a la falta de uso de la beca original.

VII. ELEGIBILIDAD MÁXIMA

Las becas para campamentos gratuitos están limitadas a dos niños por familia.

La financiación de las becas está disponible por orden de recepción de la solicitud.

VIII. CANCELACIÓN

Los beneficiarios de becas que proporcionen información de elegibilidad falsa o incompleta a la Ciudad perderán inmediatamente su beca. Las cuentas familiares que tengan un saldo vencido para cualquier programa de PARD no serán elegibles para una beca hasta que el saldo haya sido pagado en su totalidad.
